General Instructions (SAPS 520)

1. Should you **NOT** complete **ALL** sections as indicated, your application will **NOT** be approved,
2. Complete the application in **BLACK** ink. (Don't even think of using blue ink),
3. Not all sections of the form apply, but you **STILL** have to **SUBMIT ALL 8 PAGES**,
4. Date format is **YYYY-MM-DD**

ONLY complete the following Sections:

Page 2 of 8 : Section D : Type of Permit

Tick number 5 (temporary import or export permit)

Page 2 of 8 : Section E : Particulars of Applicant

Complete the whole section from 1 thru 25.4

25.1 to 25.4 have to be completed, even if you are traveling alone

They will need these particulars (spouse / partner / contact) in case of an emergency

Page 4 of 8 : Section G : Import and/or Export Details

Complete the section from 1 thru 9.2

IMPORTANT: The date format is **YYYY-MM-DD**

Page 5 of 8 : Section I : Details of Firearms

Complete all requested details about firearms and ammunition.

Note I - 1.7: "Barrel Serial Number" - not necessary if barrel is solidly connected to the receiver, as are most bolt action rifles, and the receiver has a serial number and the barrel does not have a serial number. This is only necessary if the barrel has a different serial number than the receiver's serial number or if there is no serial number on the receiver and the only serial number is located on the solidly attached barrel, as in some custom made bolt action rifles.

Page 6 of 8 : Section I : Declaration by *person who is lawfully in possession* of the firearm

Gun Permit Checklist

1. SAPS 520 Application: completed in back ink.
2. Passport: Copy of photo page.
3. Airline ticket: Copy of return ticket to country of origin.
4. Firearm license or proof of ownership: **Customs Form 4457 (personal effects taken abroad).**
5. Proof of export from the country of origin: **Customs Form 4457.**
6. Invitation letter from the outfitter: Professional hunter with his outfitters number and license number.

Note: If you do not secure your permit in advance, do not sign the gun permit! You must sign in front of the So African Police!

Riflepermits.com can hand deliver your pre-authorized permit to you on arrival. Cost is \$90.00. You must **mail** all the relevant documentation at least **21 days prior** to your arrival in South Africa.

In-transit permit for South Africa

If you overnight in South Africa with firearms you must secure the “in-transit permit” even though you are not hunting.

The procedure for the "in-transit permit" for a hunter is exactly the same as the procedure for an "import permit".
